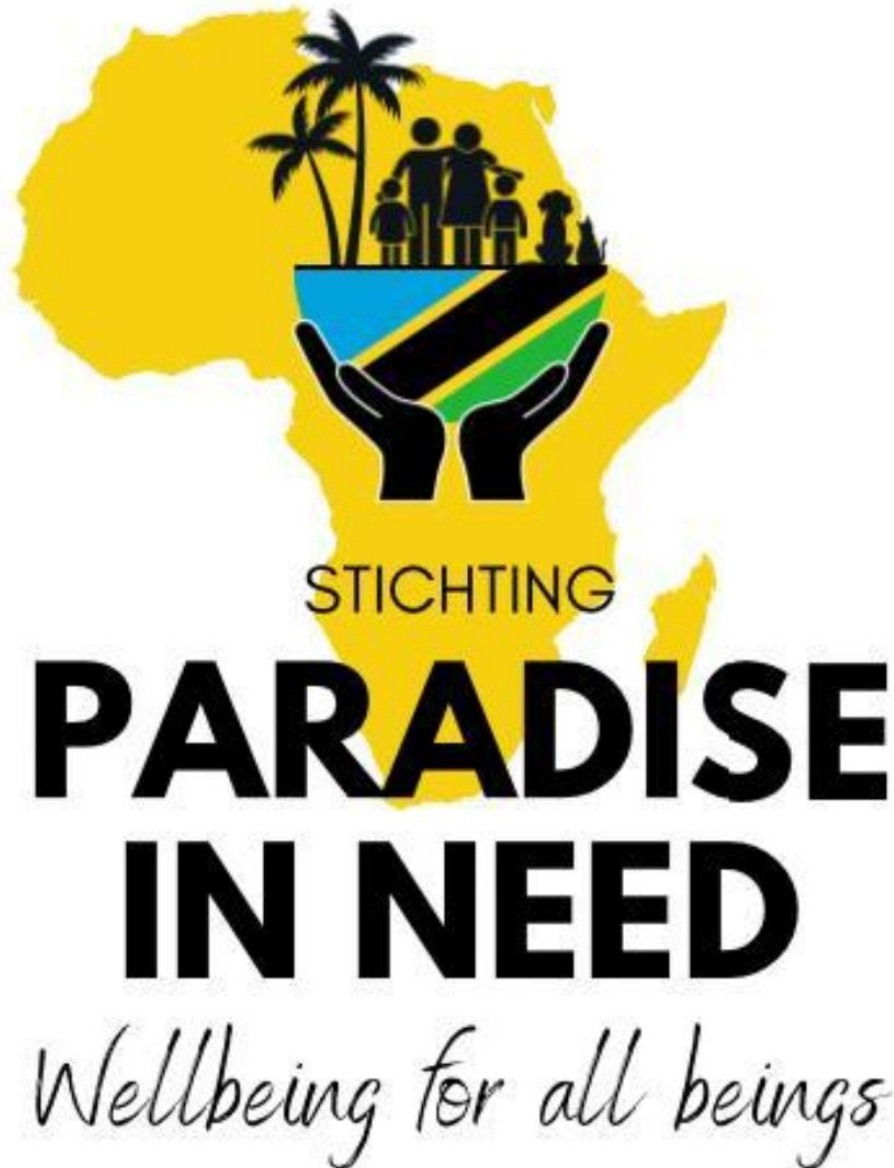

## Introduction

The Paradise in Need Foundation aims to improve the health and well-being of both the people and the animals on the African island of Mafia. The poverty of the local population and the beauty of the island have deeply affected the board members. This has resulted in the establishment of this foundation in 2024.

The foundation focuses in random order on improving:

- The medical facilities.
- Promoting food security.
- Protecting the animals on the island.

The first year of the foundation consisted of a few action points for the board, namely:

1. Establishment of the foundation
2. Obtaining a bank account
3. Setting up a good website
4. Obtaining the ANBI status.

Points 1 to 4 have all been completed.

The board consists of Anne Schaap, Astrid Molien and Raymond Ordelmans.

The positions of secretary, treasurer and chairman are divided annually among the board. Meetings are held several times a year, both face to face and via video link.

The board pays a personal contribution of € 30.00 per month from their own resources to pay for the running costs of the foundation.

The board is unpaid. The board therefore receives no remuneration for its tasks. The board members have not yet made use of the opportunity to declare their expenses.

The costs incurred for the establishment of the foundation were all paid for from our own resources.

We hope that with this foundation we can contribute in a positive way to the preservation of this piece of paradise on earth.

## 1. Our mission

Our mission is social entrepreneurship with the aim of creating a better world. We strive to sustainably restore the health and vital balance of people and the earth on the beautiful island of Mafia. We do this by providing medical care, promoting sustainable agriculture and protecting animals.

## 2. Our goals

### • **Goal 1: Improve healthcare**

**Current situation:** Many families on Mafia Island do not have financial resources for medical care. The available medical facilities are scarce, primitive and not accessible to everyone.

**Solution:**

Raising funds for the Uzima Health Center, a general practice led by Dr. Mbogo Kija.

**Location:** Mbweni, northern part of Mafia Island, with 25,000 inhabitants without medical care in the immediate vicinity.

**Goals:** Dr. Mbogo aims to provide 24-hour acute care and improve medical facilities.

**Time horizon:** 2024 and beyond.

**Actions:** Fundraising campaigns, collaboration with local and international medical networks. A GoFundMe campaign has been set up from Africa in which the foundation's bank account has been used in consultation. The deposited money was transferred in 2025.

### • **Goal 2: Establish food forests**

**Current situation:** Farming families on the island can often only just make ends meet on their land. They use incineration for monoculture such as rice and maize, which leads to deforestation and soil impoverishment. The one-sided diet patterns increase the diseases in the community.

**Solution:**

Permaculture education to local farmers, led by Mr. Ludovic Bourdon.

**Location:** Mbweni.

**Goals:** To create sustainable food forests, train farmers in permaculture and thus restore the ecological balance.

**Time horizon** 2024 and beyond. (Has already been set in motion in 2024 with its own financial resources.)

**Actions:** Annual courses, initiating food forest projects, and continuing education to ensure sustainable agricultural practices.

### • **Goal 3: Improve animal care** (especially street dogs and cats)

**Current situation:** There is no veterinarian or animal shelter on the island, which leads to a lot of suffering for these animals. Sick and neglected animals can also pose a health risk to the local population.

**Solution:**

Support for a local initiative, led by Francesca & Marco Bensa, to protect these animals and provide medical care.

**Location:** Whole island, with a focus on the north.

**Goals:** To develop an animal shelter and a medical practice for dogs and cats. Treatment of injuries, sterilization and finding suitable adoptive families for the animals.

**Time horizon:** 2024 and beyond. (The board has already started these local activities in 2024 with its own financial resources and money from the foundation. See financial accountability Flammetta Francesca Bensa).

**Actions:** Fundraising, setting up an animal shelter, and working with local community for awareness and support.

### 3. Strategy and action plan:

To achieve the above-mentioned goals, the Paradise in Need Foundation will implement the following strategies and actions:

- **Fundraising campaigns:** Organizing local and international events, crowdfunding, and applying for grants.
- **Collaboration with local and international organizations:** Collaborate with medical organizations, farmers' associations, and animal rights organizations to mobilize expertise and resources.
- **Education and Training:** Offering training and workshops for local farmers and health workers to promote sustainable practices.
- **Sustainable policy:** Contributing to sustainable initiatives in the field of agriculture, animal welfare and health that respect the ecological balance.

### 4. Expected results:

- **Improved access to health care** for the 25,000 people in Mbweni and surrounding areas.
- **Sustainable food** through the construction of permaculture projects and food forests, which will contribute to better food security and less dependence on monoculture.
- **Better animal care** by establishing an animal shelter and providing medical care to dogs and cats.

### 5. Monitoring and Evaluation:

The success of the projects will be regularly evaluated by:

- **Collect qualitative and quantitative data** on the number of patients treated, the progress of the permaculture projects, and the animals that have been helped.
- **Feedback from locals** and partners is collected to measure the impact and adjust the strategies where necessary.

### 6. Application procedure for compensation:

Only parties that commit to our objective and also have their funds benefit one of our goals can submit a request for compensation.

Parties who want to apply for compensation must submit a project plan for each subject.

Applications should always be aimed at improving the health and welfare of both the people and animals on the African island of Mafia, both directly and indirectly.

### 7. Financing and budget:

The necessary financial resources for the implementation of this plan will be raised through:

- Private and corporate sponsors.
- Crowdfunding campaigns.
- Partnerships with other foundations and NGOs.

A detailed budget plan is created to ensure that all resources are used efficiently and effectively to achieve the set goals.

## 8. Call to action

We ask companies, foundations, and individuals to support us in our mission to make a positive change in the lives of the people, animals, and nature on Mafia Island. Every contribution helps to improve the health, well-being and future of this unique island.
